The Zambezi Watercourse Commission (ZAMCOM) has received a grant from the African Development Bank towards the costs of the Regional (ZAMCOM) Project of the Programme for Integrated Development and Adaptation to Climate Change in the Zambezi Basin (PIDACC Zambezi) and intends to apply part of the agreed amount for this grant to payments under the contract for Landscape Financing, Resource Mobilization and Capacity Building.

PIDACC Zambezi's development objective is to strengthen regional cooperation in building the resilience of the Zambezi River Basin communities to climatic and economic shocks, through promoting inclusive, transformative investments, job creation and ecosystem-based solutions.

The objective of this assignment is to mobilize financial resources and build partnerships that can sustain and scale climate action and landscape restoration initiatives through landscape financing, resource mobilization, and engagement with cooperating partners.

The specific tasks to be carried out by the Consultant shall include the following,

- a) Mapping of strategic cooperating partners,
- b) Packaging of potential projects with the Zambezi Watercourse,
- c) Organizing International Cooperating Partners (ICPs) meetings at the regional level and international level,
- d) Conducting advocacy and roundtable meetings with cooperating partners,
- e) Initiate, promote and support resource mobilisation initiatives and,
- f) Capacity building.

ZAMCOM now invites eligible firms to indicate their interest in providing these services. Interested firms must provide information indicating that they are qualified to perform the

services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Firms may constitute joint ventures to enhance their chances of qualification.

Eligibility criteria, establishment of the short-list and the selection procedure shall be in accordance with the African Development Bank's ***Procurement Policy for Bank Group Funded Operations, October 20215 and effective 1 January 2016***, which is available on the Bank's website at <http://www.afdb.org>.

A consultant will be selected in accordance with the ***Quality and Cost Based Selection method*** set out in the said Policy.
