The Zambezi Watercourse Commission (ZAMCOM) has received a grant from the African Development Bank towards the costs of the Regional (ZAMCOM) Project of the Programme for Integrated Development and Adaptation to Climate Change in the Zambezi Basin (PIDACC Zambezi) and intends to apply part of the agreed amount for this grant to payments under the contract for **Developing messages and knowledge products and providing communication support to the programme for PIDACC Zambezi as an individual consultant.**

PIDACC Zambezi's development objective is to strengthen regional cooperation in building the resilience of the Zambezi River Basin communities to climatic and economic shocks, through promoting inclusive, transformative investments, job creation and ecosystem-based solutions.

The objective of this assignment is to develop messages and knowledge products for PIDACC Zambezi with the aim of raising awareness and visibility for ZAMCOM's activities, in particular, the implementation of the Strategic Plan for the Zambezi Watercourse (ZSP). The scope under this assignment include;

- a) Data collection and stakeholder consultations: Interviews; key environmental indicators, gender disaggregated data etc.
- b) Prepare two periodic state of the environment reports;
- c) Conduct one training for a team of technical reviewers for the reports;

- d) Prepare and publish at least 10 fact sheets, policy reviews/briefs and outlooks;
- e) Support the production of at least 2 documentaries;
- f) Support establishment of information sharing platforms on water accounting (surface and ground).

The assignment will be done over a period of 24 months.

ZAMCOM now invites eligible individual consultants to indicate their interest in providing these services. Interested individual consultants must provide information indicating that they are qualified to perform the services (Curriculum Vitae (CVs), description and experience in similar assignments and appropriate skills etc.

Eligibility criteria, the establishment of the short-list and the selection procedure shall be in accordance with the African Development Bank's **as specified in the Bank's Procurement Framework**, **dated 2015**, which is available on the Bank's website at https://www.afdb.org/en/projects-and-operations/procurement/new-procurement-policy.

A consultant will be selected in accordance with the Individual Consultant selection method set out in the said Policy.
